아시아 증시는 혼조세로 마감 했습니다. 중국 시장은 은행 및 보험 규제 당국이 자금의 유입과 시장의 변동성을 관리하는 방안을 연구 중이라는 언급과 함께 소비재 주들이 외국인 매도세를 겪으며 하락했습니다. 일본 증시는 일부 투자자들이 최근 랠리로 인한 수익실현을 하며 하락했습니다. 한국의 주가는 미국의 새로운 경기 부양책과 긍정적 수출 지표, 그리고 전일 미국 증시의 상승세로 상승 했습니다. 인도 증시는 자동차 섹터가 월별 판매량 호조를 보이는 가운데 IT주 주도 하에 상승 했습니다. 유럽 증시는 채권 시장의 안정이 증시에 숨통을 틔워주었고, 원유 와 금속 가격의 상승으로 원자재 연계 주식들이 반등하며 소폭 상승했습니다. STOXX 600은 구리 가격이 10년 만에 최고치에 근접하면서 광업주 주도 하에 0.2% 상승했습니다. 한편, 독일 원격 연결 소프트웨어 기업인 TeamViewer는 일선 근로자를 위한 증강현실 애플리케이션 전문 회사인 Upskill을 인수했다고 밝힌 후 4% 이상 상승했습니다. 미국 증시는 애플과 테슬라에 의해 하락세를 보였고, 투자자들이 경기부양책의 승인을 기다리는 동안 재료주는 상승했습니다. S&P 500 기술 섹터 지수는 1.6% 하락하며, 채권 시장의 매도세가 고평가 종목에 대한 우려를 촉발하면서 지난달 말보다 하락폭이 확대되었습니다. 한편, Reddit의 인기 있는 WallStreetBets에 대한 주식들이 관심을 끌면서, 크게 약화된 주택담보대출 제공업체인 Rocket Companies는 사흘 연속 상승세를 보이며 71%나 급등했습니다. **미 국채 금리**는 지난 주 중앙 은행이 채권 시장의 변동성을 면밀히 주시하고 있다고 한 연준 고위 관리가 언급하면서 소폭 하락했습니다.

국제 유가는 코로나 바이러스 사태로부터 경제가 회복되기 시작할 것이라는 예상과 함께 석유수출국기구 (OPEC)와 그 동맹국들이 금주 후반 열리는 회의에서 공급 제한 조치를 완화할 것이라는 기대감으로 하락했습니다.
