

아시아 증시는 대체로 상승세로 마감했습니다. 중국 증시는 새로 출범한 국경 간 투자 계획 ETF Connect에 힘입어 상승했지만, COVID-19 감염 증가 조짐으로 인해 상승폭이 제한되었습니다. 한국의 주가는 인플레이션을 막기 위한 금리 인상이 경기 침체를 촉발하고, 내년 미국 경기 침체에 대비해야 한다는 투자자들의 우려로 하락했습니다. 일본 시장은 7월로 접어들며 전례 없는 폭염에 계속 대처하면서 유틸리티 기업 주도로 상승했습니다.

유럽 증시는 4% 상승한 원유 및 가스주 주도로 상승 마감했으며, 매우 높은 소비자 물가 보고서가 유럽중앙은행의 금리 인상에 대한 근거를 확고히 하며 투자자들은 유로존 인플레이션 데이터에 주목했습니다. Spirax-Sarco Engineering은 Vulcanic Group of Companies를 인수하기 위해 프랑스 사모펀드 Qualium과 독점 협상을 시작한 후 2.5% 이상 상승했습니다. 그러나 Grafton Group은 Gavin Stark가 CEO에서 물러날 것이라고 발표한 후 약 7.5% 하락했습니다.

국제 유가는 OPEC 생산량 감소, 리비아 불안, 러시아 제재에 따른 공급 부족에 대한 우려가 글로벌 경기 침체에 대한 두려움을 상회하면서 최근 하락세를 반전시키며 상승했습니다.
