

아시아 증시는 대체로 상승 마감했습니다. 중국 증시는 COVID-19 확산 우려가 새로운 경기 부양책에 따른 낙관론을 압도하면서 하락했습니다. 한국의 주가는 미 연준 (Fed)이 한국은행과 비슷한 입장을 취한 통화긴축 완화 신호를 보내며 상승했습니다. 일본 시장은 미 연준 (Fed)의 금리 인상 속도 둔화에 대한 기대감으로 전일 미 증시가 강세를 보이며 상승했습니다.

유럽 증시는 11월 연준 (Fed) 회의록이 금리 인상 속도가 둔화될 것이라는 신호를 보낸 후 부동산 주 주도로 상승세로 마감했습니다. 한편, 독일 기업 신뢰도에 대한 예상보다 나은 보고서는 유로존 최대 경제국의 완만한 경기둔화에 대한 투자자들의 희망을 높였습니다. 세계 최대 광고회사 Adevinta와 폴란드 보험사 PZU의 주가는 3분기 실적 호조 이후 각각 6% 이상 급등했습니다.

미 증시는 추수감사절 휴일로 휴장했습니다.

국제 유가는 G7 국가에 의해 제안된 러시아 석유 가격 상한선이 현재 거래 수준보다 높은 것으로 간주되어 타이트한 공급에 대한 우려가 완화되면서 하락, 2개월 내 최저 수준을 유지했습니다.
