아시아 증시는 대체로 상승 마감했습니다. 중국 증시는 글로벌 금리가 내년 낮아질 것이라는 기대감이 커지면서 상승한 반면, 투자자들은 국내 경기 회복에 신중함을 유지했습니다. 한국의 주가는 미 연준의 금리 인상이 끝나고 경제가 회복세를 유지하고 있다는 낙관론으로 상승했습니다. 일본 시장은 공휴일 휴장했습니다. 호주 증시는 중앙은행 총재가 전일 인플레이션에 상당한 정책 대응이 필요하다고 경고한 이후 하락했습니다.

유럽 증시는 에너지주 주도로 상승 마감했고, 투자자들은 유로존 인플레이션 하락 관련 조심스럽게 낙관적인 입장을 보인 ECB 10월 회의록을 소화했습니다. 원유 및 가스주는 약 1.5% 상승한 반면 여행주는 1% 넘게 하락했습니다. Novo Nordisk는 큰 인기를 끌고 있는 체중 감량 및 당뇨병 치료제의 생산을 늘리기 위해 23억 달러를 투자한다고 발표하면서 1% 가까이 상승했습니다. 그러나 Endesa는 2023년 수익 전망을 하향 조정, 2% 넘게 하락했습니다.

미국 증시는 공휴일 휴장했습니다.

국제 유가는 OPEC+가 장관급 회의를 연기하면서 산유국들이 감산량을 당초 예상보다 적게 줄일 수 있다는 전망이 나오며 하락했습니다.
