아시아 증시는 금요일 혼조세로 마감되었습니다. 중국 증시는 거의 변동이 없었지만 새로운 부양책과 긍정적 지표에 힘입어 주간 단위 상승세를 보였습니다. 한국 시장은 삼성과 SK 하이닉스의 주가가 하락하면서 하락했습니다. 일본 시장은 유럽의 새로운 코로나바이러스 관련 제한으로 빠른 세계 경제 회복에 대한 희망이 흐려지면서 하락 마감했습니다. 호주 증시는 리우 틴토가 중국 밖의 철강 생산에 대한 우려를 제기하며 광업주가 약세를 보이며 소폭 하락했습니다. 인도 주식은 금속과 은행주 주도 하에 상승세를 보였습니다.

유럽 증시는 금요일 코로나바이러스 백신이 연말 전에 미국에서 출시될 수 있을 것이라는희망과 분기 실적 호조세에 힘입어상승했습니다. STOXX 600 지수는1.3% 상승 마감했습니다. 기업관련으로는 Thyssenkrupp는Liberty Steel이해당기업의 철강사업부에 구속력이 없는 인수제안을했다고 발표하면서 10%이상 급등했습니다. LVMH는루이비통핸드백의 매출회복에7%이상 상승했습니다. Volvo는예상보다 견조한 실적 발표 후에3%이상 상승했습니다.

**미국 증시**는 금요일 백신 개발 일정에 대한 명확성과 예상보다 나은 소매 판매 지표가 투자자들을 다시 시장에 불러들임으로써 상승세를 보였습니다. Pfizer는 11월에 백신에 대한 미국 허가를 신청할 수 있다고 발표한 후 3% 이상 상승했습니다. Schlumberger NV는 원유 가격 하락과 수요 감소로 인해 3분기 연속 손실을 기록한 후 8% 이상 하락했습니다. Peloton Interactive는 인기 있는 운동용 자전거의 페달 불량 리콜을 발표한 후 3% 이상 하락했습니다.

미 국채 금리는 지난 9월 미국 소매 판매량이 예상보다 증가했고 10월 초 소비자 신뢰도가 개선된 것으로 나타난 경제지표의 영향으로 소폭 상승했습니다.

국제 유가는 미국과 유럽의 코로나바이러스 환자 급증으로 인해 세계 최대 연료 소비의 두 지역에서 원유 수요가 계속 감소할 것이라는 우려로 인해 소폭 하락했습니다.
